

# OLT Offshore LNG Toscana Annual and multiyear allocation process

June 2024



#### July 2024 auctions



- Annual and multiyear capacity is offered on PAR platform through ascending clock auctions, according with art. 17 of the European regulation 459/2017
- Reserve prices are determined according to resolution 288/2023/R/GAS, whose detailed formula is published on OLT website
- Transportation costs are assimilated into the bid. Within 15 days from the exit of the auctions, the awardees may request to be charged of the transport tariffs as annually approved by the Authority instead of the one assimilated into the awarding price, possibly adjusted with the relevant rate of inflation
- The regasification capacity is offered in 165,000 m<sup>3</sup> slots

From July 15<sup>th</sup>, 2024, regasification capacity will be auctioned on PAR platform considering the here below the reserve prices

### What for bidding on July 2024 auctions



In order to participate to the July auctions, by July 10th, 2024, each applicant that meets the service conditions shall



sign the capacity contract in accordance with the provisions of clause 2.1.7 of the regasification code



provide adequate financial guarantees in accordance with the provisions of Clause 3.1.1.1 of the Regasification Code. Minimum financial guarantee duration is of two years, to be renewed one year in advance. The amount to be guaranteed is 1/3 of the maximum annual commitment



be eligible to operate on PAR, the regasification auction platform managed by GME, in accordance with the relevant rules
